AND DON'T WORRY – THERE ARE STORES THAT WILL BE HAPPY TO TAKE CARE OF YOUR NEEDS. THE TOUR DOES ENTAIL SOME WALKING OVER GRASSLANDS AND SIGHT HILLS, SO PLAN ACCORDINGLY. BUT NOT HIKING BOOTS! DON'T FORGET YOUR CAMERA!

WHAT HAPPENS WHEN WE ARRIVE AT EDINBURGH'S AIRPORT? YOU'LL GATHER YOUR BAGS, CLEAR CUSTOMS. MEET EVERYONE AT THE TO BE DESIGNATED AREA AND HEAD OUT ON OUR TELFORD COACH. LATER ON, WE'LL COVER THE MONEY ISSUES AND MAKE SUGGESTIONS. AND YES, CREDIT CARDS ARE ACCEPTED THROUGHOUT SCOTLAND.

CELL PHONES (THEY ARE CALLED MOBILE PHONES IN SCOTLAND)? WE SUGGEST YOU CALL YOUR PHONE CARRIER AND EXPLORE AN INTERNATIONAL PLAN. SEVERAL OFFER A PER DAY AND PER USE DEAL.

IS THERE FREE WIFI? OUR HOTELS HAVE FREE WIFI. MAKE SURE YOU ARE ON IT!!

Flights arriving on Sunday, August 6th cannot guarantee your arrival in time to meet the group by 8:45.

As our participants come from across the country, necessitating pre-transatlantic flights, airfare charges and fees can vary and many have asked to use air miles or other means of ticket purchase. Others have plans to arrive prior to or to remain after the Tour. So that you can tailor your dates and individual departure and return locations, each participant is responsible in procuring his or her own air transportation to and from the EDINBURGH AIRPORT.

Airfare bookings are your responsibility. Failure to purchase airfare will result in cancellation of your tour with no refunds.

2023 COVID-19 WAIVER OF LIABILITY/HOLD HARMLESS AND AGREEMENT

2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to participate in the tour(s) as named below as described as Activities.

3. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and participating in the Activities and hereby release, waive, discharge, and covenant not to sue (on behalf of myself and the traveling companion as listed on the tour Enrollment Form whom I have the capacity contract), herein after are known as the RELEASEES including EAST OF THE HEBRIDES, its owners, officers, directors, agents, employees, contractors, partners, and CHARLIE ZAHM and any musicians performing with Charlie Zahm, any liability related to COVID-19 which might occur as a result my being on the premises and participating in the Activities.

4. I shall indemnify, defend and hold harmless forever the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.

5. It is my express intent that this Waiver and Hold Harmless Agreement shall bind any assigns and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES.
